

# Name the New Portal Contest

Official Competition Rules

THE "NAME THE NEW PORTAL" CONTEST (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN CANADA ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAWS. NO PURCHASE IS NECESSARY. VOID WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES"). PARTICIPANTS MUST BE AT LEAST THE AGE OF MAJORITY IN THEIR PROVINCE OR TERRITORY OF RESIDENCE IN ORDER TO ENTER OR WIN.

THE CONTEST IS SPONSORED BY THE GOVERNING COUNCIL OF THE UNIVERSITY OF TORONTO (THE "UNIVERSITY OF TORONTO") LOCATED AT **OFFICE OF THE VICE-PROVOST, STUDENTS SUITE 225, 27 KING'S COLLEGE CIRCLE, UNIVERSITY OF TORONTO, TORONTO, ON M5S 1A1**. ## Eligibility

To be eligible for this Contest, an individual must:

- a) be a student registered and in good standing at the University of Toronto for the duration of the competition and must be a resident of Canada, excluding the Province of Quebec.
  Note: International students who hold valid student visas are considered temporary residents of Canada and eligible to participate in the contest;
- b) be at least the age of majority in his/her province or territory of residence (18 in Ontario);
- c) be the sole owner of all right, title and interest (including copyright) in and to the Work (as defined below) submitted in connection with the Contest.

Members of the Judging Panel (as defined below), their families and cohabitees are not eligible to participate in the Contest. Members of the University of Toronto Governing Council, as well as its faculty, employees and agents, their families and their cohabitees are also not eligible to participate in the Contest.

The University of Toronto shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the University of Toronto for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The University of Toronto reserves the right, in its sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

### **Contest Period**

The Contest begins at 10:00am on Monday, October 30, 2017 Eastern Daylight Time ("EDT") and ends at, 5:00pm on Monday, November 22, 2017 Eastern Standard Time ("EST") (this is the "Contest Period") after which time the

Contest will be closed and no further entries shall be accepted. The date and time of the University's server at <a href="http://toolboxrenewal.utoronto.ca/contest">http://toolboxrenewal.utoronto.ca/contest</a> is considered the official time for determining the beginning and end of the Contest Period.

### How to Enter

- a) There is no purchase necessary to enter the Contest. Enter by completing and submitting the online form at <a href="http://toolboxrenewal.utoronto.ca/contest">http://toolboxrenewal.utoronto.ca/contest</a> or in the case of entrants with a disability, by the method described under "Accommodation" below. No entries will be accepted by any other means. Incomplete entries will not be accepted.
- b) By participating in this Contest, entrant represents and warrants that: (i) the Work does not contain any material that is libelous, defamatory, profane or obscene; (ii) the Work is original and all right, title, and interest (including copyright) therein and thereto is owned and/or controlled by the entrant to the full extent necessary to enable the University of Toronto to use the Work as contemplated by these Contest Rules; and (iii) the Work does not infringe upon the intellectual property or other statutory or common law rights of any third party.
- c) The number of entries submitted per person during the Contest Period is unlimited.
- d) All entries, including the Work, become the sole property of the University of Toronto and none will be returned for any reason. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged or garbled.
- e) Entries must be received in full by the University of Toronto no later than the end of the Contest Period. Entries received, in whole or in part, after the Contest Period will not be accepted. An entry will be considered as received once all of the data comprising the completed online form are received at the University's server.
- f) Entries received online shall be deemed to be submitted by the authorized account holder of the e-mail address associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Each selected entrant may be required to provide the University of Toronto with proof that the selected entrant is the authorized account holder of the e-mail address associated with the winning entry.

### Legality

As the entries may be enjoyed by the broader University of Toronto community, all entries must comply with the law and applicable University of Toronto policies and be appropriate for use by University of Toronto. Any entry which in the sole discretion of the Judging Panel (as defined below) is deemed inappropriate or is considered not to be in full legal compliance for use in online publications will be rejected.

### Winner Selection

The process to select a Winner (defined below) is as follows:

All eligible entries submitted during the Contest Period will reviewed by the Judging Panel (as defined below). The Judging Panel will review the eligible entries between October 30 and November 22, 2017 (the "contest period") in Toronto, Ontario and may select a winner (the "Winner"). If a Winner is selected, the Judging Panel will notify the selected entrant. Before being declared the Winner, the selected entrant shall be required to comply with the Contest Rules and sign and return the Release (as defined below).

- a) The Judging Panel will consist of members of the University of Toronto community Steering Committee. The selection of the Judging Panel is solely within the discretion of the University. Judging will be based on the Judging Panel's discretion, but they will consider criteria such as connection to U of T themes, appropriateness of content, and concept. The Judging Panel in its absolute discretion, may select the potential winner from among the entries based upon the above criteria. The decision of the Judging Panel is final and binding and may not be challenged in any way. The Judging Panel is not obligated to select a Winner.
- b) If a Winner is selected, the selected entrant will be notified by e-mail and must respond within five business days of the date notification is sent, by responding to the contact information (phone/email) provided in the notification.

- d) If the selected entrant does not respond within five business days of the date the notification was sent, he/she will be disqualified and will not receive the Prize (as defined below) and another entrant may be selected in the University of Toronto's sole discretion. The University of Toronto is not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the University of Toronto to receive a selected entrant's response.
- e) The Winner must correctly answer a time limited, mathematical skill testing question before being awarded the prize. Failure to correctly answer such question in the allotted time will result in disqualification of that entry

#### Prize

- a) There is a prize available to be won by the selected entrant as follows: \$250 U of T Bookstore Gift Certificate (the "Prize").
- b) The Prize will be distributed with in fourteen (14) business days after the selected entrant has been successfully contacted and notified of his/her Prize and fulfilled the requirements set out herein.
- c) The winner must accept the Prize in person, showing a valid TCard (University of Toronto campus ID card).
- d) The Prize must be accepted as awarded and cannot be transferred, assigned, or substituted, except at the sole discretion of the University of Toronto. The prize has no cash surrender value. The University of Toronto reserves the right, in its sole discretion, to substitute a prize of equal or greater value if a Prize (or any portion thereof) cannot be awarded for any reason.
- e) The odds of winning depend on the number of eligible entries received.

### Release

The executed Release must be returned within ten (10) business days of the date indicated on the accompanying letter or the selected entrant will be disqualified and the Prize forfeited.

The entrant agrees that the opportunity to participate in the Contest is sufficient consideration for this assignment and waiver. The entrant hereby confirms that the Work is an original work, solely created by the entrant, and that no third party participated as an author, co-author, photographer or otherwise in the creation of the Work or any part thereof. The University of Toronto assumes no responsibility for any claims of infringement of rights to copyright, privacy and/or personality, and all such liability shall remain with the entrant. The University of Toronto reserves the right to exclude any Work on the basis of concerns relating to the rights of third parties, including but not limited to privacy, copyright, defamation, rights of personality, obscenity or hate speech, as determined by the University of Toronto in its sole discretion.

The University of Toronto assumes no responsibility or liability for lost, late, unintelligible/illegible, falsified, damaged, misdirected or incomplete entries, notifications, responses, replies or any Release, or for any computer, online, software, telephone, hardware or technical malfunctions that may occur, including but not limited to malfunctions that may affect the transmission or non-transmission of an entry. The University of Toronto is not responsible for any incorrect or inaccurate information, whether caused by website users or by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. The University of Toronto assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries.
